


Figure 1-1 Distribution of track lines and sightings of North Atlantic right whales 2010 to 2017




Figure 2-1 Distribution of track lines and sightings of rarely detected cetaceans 2010 to 2017




Figure 3-1 Distribution of track lines and sightings of seals 2010 to 2017




Figure 4-1 Distribution of track lines and sightings of unidentified dolphins 2010 to 2017




Figure 5-1 Distribution of track lines and sightings of unidentified whales 2010 to 2017
